As requested under Resolution 19 GA 8 (<http://whc.unesco.org/en/decisions/6423/>), the Director-General invites States Parties to make unrestricted supplementary **voluntary** contributions to the World Heritage Fund in addition to their mandatory contributions. By its Decision 40 COM 15 (<http://whc.unesco.org/en/decisions/6854/>), the World Heritage Committee endorsed options 1, 4 and 5 of Resolution 19 GA 8, as they were found applicable alternatives. By the same decision, the World Heritage Committee also endorsed the proposal of document WHC-15/20.GA/8 (<http://whc.unesco.org/archive/2015/whc15-20ga-8-en.pdf>) to apply on a voluntary basis a minimum contribution by categories. to complement the assessed contributions.
